EMERGENCY MOTION TO COMPEL A SIGNATURE ON EMERGENCY ORDER TO VOID JUDGMENT VIA CONSTITUTIONAL GROUNDS AND STATUTORY OBLIGATIONS	

1 Now comes Stacy Lynne, mother of Jaden, being of sound mind and body and
 2 possessing total natural and constitutional rights, to demand that Chief Judge Stephen
 3 J. Schapanski sign the legally and lawfully filed **“EMERGENCY ORDER TO VOID**
 4 **JUDGMENT”**. The emergency motion for Julie Kunce Field’s recusal and
 5 disqualification was filed on September 13, 2012.

6 **The 10th U.S. Circuit Court of Appeals set precedence on Wednesday, December**
 7 **19, 2012, when the three-judge panel ruled that children who have been removed from**
 8 **their parents by the state have constitutional rights and that government employees who**
 9 **participated in that removal are not immune from prosecution.**

10 Jaden was removed from Stacy Lynne’s custody without cause, without
 11 justification, without due process of law, without findings of fact and conclusions of law,
 12 and in violation of the Colorado Revised Statutes, the Colorado Rules for Civil
 13 Procedure, the Colorado Rules of Evidence, the Colorado Constitution and the United
 14 States Constitution. The evidence of Julie Kunce Field’s statutory violations and crimes

15 are contained in the official written record in case number 2011 DR 444. Additionally,
16 the record of Julie Kunce Field's crimes has been legally and lawfully filed with the 8th
17 Judicial District, the Larimer County Sheriff's Office, the Fort Collins Police
18 Department, the Weld County Sheriff's Office, the Larimer County Commissioners, the
19 City of Fort Collins Mayor, Councilors, City Attorney, City Manager, and with the
20 people.

21 Jaden's health, safety, well-being and best interests are being viciously ignored by
22 Stephen J. Schapanski, Chief Judge of the 8th Judicial District, Fort Collins, Colorado,
23 Larimer County because he is refusing to sign the legally correct and lawfully valid VOID
24 JUDGMENT.

25 Therefore, a signature on the ORDER FOR VOID JUDGMENT is legally and
26 lawfully demanded so that Stacy Lynne can legally and lawfully proceed with additional
27 legal and lawful actions to save Jaden from the brutal abuse he is suffering due to Julie
28 Kunce Field's illegal and unlawful actions against Jaden and his mother, Stacy Lynne.
29 *This court's refusal to rule on the VOID JUDGMENT constitutes legally and lawfully*
30 *defined cruel and unusual punishment against Stacy Lynne and Jaden; these two*
31 *people have never even committed a single crime.*

32 I, Stacy Lynne, am a woman possessing all natural and constitutional rights, and being of sound
33 mind and body, do swear under penalty of perjury that I have read the foregoing **EMERGENCY**
34 **MOTION TO COMPEL A SIGNATURE ON EMERGENCY ORDER TO VOID**
35 **JUDGMENT VIA CONSTITUTIONAL GROUNDS AND STATUTORY OBLIGATIONS.**
