BACKGROUND

- Julie Kunce Field became officially involved in Jaden's case (11 DR 444) when she sat on the bench at a "Permanent Orders Hearing" on November 15, 2011.

Corporal Ryan Berg had multiple official crime reports filed against him

Corporal Ryan Berg vacated his employment with the Larimer County

66	3. Julie Kunce Field is directly associated with powerful adversaries of Stacy
67	Lynne. Those adversaries have been publicly exposed and successfully defeated
68	or impaired. Stacy Lynne's investigative journalism and her public efforts to
69	protect small business owners, minority populations and disadvantaged
70	populations have directly and adversely affected those listed on the Conflict of
71	Interest Flow Chart. See attached flow chart and written explanation.
72	a. Julie Kunce Field claims in her denial that Stacy Lynne's facts about
73	Julie Kunce Field's conflicts of interest are mere speculation.
74	b. The truth reveals that Julie Kunce Field is ignorant of the facts and/or
75	she is intentionally using her position on the bench to abuse an innocent
76	woman by painting Stacy Lynne incorrectly.
77	c. These verifiable conflicts of interest are sufficient grounds for Julie
78	Kunce Field's recusal and disqualification.

79	4. Julie Kunce Field held an illegal and secret hearing on September 13, 2012.
80	a. Julie Kunce Field lied about the Larimer County Sheriff's Office and
81	Larimer County Justice Center Personnel involvement in her secret
82	hearing.
83	b. Julie Kunce Field held that secret hearing because she knew the void
84	judgment is valid and that void judgment proved her crimes.
85	c. Julie Kunce Field panicked during the hearing and then lied about law
86	enforcement.
87	d. Julie Kunce Field's lies about law enforcement are sufficient grounds for
88	her recusal.
89	5. Julie Kunce Field illegally denied Rule 59 and Rule 62 motions because she
90	failed to issue the legally required findings of facts and conclusions of law.
91	a. Field failed to issue those legal findings and conclusions of law because
92	she understands she has no legal or lawful justification for her denials.
93	b. Field is protecting her bench at the expense of the law and an innocent
94	boy and his mom.
95	c. Field's illegal actions on that one legal procedure are sufficient grounds
96	for her recusal and disqualification.
97	6. Julie Kunce Field obsessively distorted the properly filed legal and lawful
98	demand for her recusal and disqualification by attempting to discredit,
99	denigrate and marginalize Stacy Lynne because of Stacy Lynne's profession as
100	an investigative journalist. Field's distortion of the facts regarding Stacy Lynne
101	is grounds alone for Field's recusal. Specifically, Field derisively accuses Stacy
102	Lynne of being a conspiracy theorist. See immediate related paragraphs below
103	On August 18, 2010, Stacy Lynne wrote an article entitled, "ICLEI is a Conspiracy
104	and That's No Theory". The article begins with a definition of "conspiracy" and that is
105	relevant here due to Field's apparent confusion about the literal definition of the word.
106	Conspiracy is defined as: an illegal, treasonable, or treacherous plan to harm or
107	destroy another person, group or entity; an agreement manifesting itself in words or
108	deeds and made by two or more persons confederating to do an unlawful act or use

unlawful means to do an act which is unlawful; a combination of persons banded

together and resolved to accomplish an evil or unlawful end (from: Webster's Third New International Dictionary, Unabridged, 2002). *Theory* is defined as an imaginative contemplation of reality. *Fact* is defined as something that has actual existence; an actual happening in time or space; physical actuality or practical experience *as distinguished from imagination, speculation or theory*. These literal definitions shall compel Julie Kunce Field to be more honest, accurate, and articulate in her future attempts to deny the truth.

Julie Kunce Field's own district attorney, Larry Abrahamson, attended a mainstream political event so that he could learn the truth about the United Nation's involvement in Fort Collins, Colorado. Nationally, millions of people who belong to the Democrat political party, the Republican political party, and people who are not affiliated with any political party are publicly speaking against Agenda 21, ICLEI, and foreign organizations that are systematically and methodically destroying the Constitutional Republic known as the United States of America.

146	leader in Jaden's case. Why? Because everybody knows there is no way that Julie	
147	Kunce Field is going to go down without taking her accomplices with her. See, crooked	
148	judges do go to jail. Only after Julie Kunce Field is placed in handcuffs with eight	
149	loaded guns pointed at her head will Julie understand by experiencing for herself what	
150	she has done to Jaden and Stacy Lynne.	
151	In jail, Julie will be stripped of her clothing. She will stand naked before	
152	strangers who will stare at her and mock her.	
153	In jail, Julie will be fed sub-human food.	
154	In jail, Julie will be housed with people who will plot how to rape her.	
155	In jail, Julie will be stripped of her children.	
156	In jail, Julie will be stripped of her husband.	
157	In jail, Julie will be stripped of her bed.	
158	In jail, Julie will be stripped of her cats and dogs.	
159	In jail, Julie will be stripped of her lifelong friends.	
160	In jail, Julie will be stripped of her identity.	
161	In jail, Julie will be known only by her state number.	
162	In jail, Julie will cease to feel human.	
163	Strangers will begin to brainwash her children and she won't be able to love or	
164	comfort them.	
165	Julie's children will lose too much weight and she won't be able to feed them.	
166	Julie's children will fail their classes at school and she won't be able to teach	
167	them.	
168	Strangers will teach her children to hate their mom through distortions and lies.	
169	And then.	
170	Julie will be a model prisoner.	

171	Julie will wait months for a scheduled visit to see her children. Julie will be told
172	on visit day that the children are sick and they won't be allowed inside the jail.
173	Julie will reschedule the visit with her children.
174	Julie will continue to be a model prisoner.
175	Julie will wait months for the rescheduled visit day to arrive so she can see her
176	children.
177	Visit day arrives and Van Hook tells Julie that she has violated a policy and her
178	children will be told that their mom did something wrong.
179	The children will be sent home without seeing their mom and believing that their
180	mom did something wrong.
181	Julie tries to tell someone, anyone! that Van Hook lied to her and to her children
182	Nobody listens to Julie.
183	And Julie Kunce Field is mute.
184	The difference between Julie Kunce Field and Jaden and his mom is obvious:
185	Julie deserves her punishment because she is guilty of crimes against humanity. Jaden
186	does not deserve the life sentence that Julie Kunce Field illegally and wickedly imposed
187	on an innocent eight year old boy.
188	What could be Julie's consolation? She can ask Sergeant Jeffrey Van Hook to
189	repeat the advice he gave to Stacy Lynne while Stacy sat handcuffed in jail on a metal
190	bench. (Remember! Julie Kunce Field ambushed Stacy Lynne by not serving Stacy an
191	order that was "effective immediately".) Sergeant Van Hook will tell Julie that she can
192	spend the rest of her life reading law books while she does life in jail. Everybody knows
193	that Julie could sure use the time to learn more about the law.
194	What do reasonable people think when they consider the length of Julie's jail
195	sentence? Julie deserves to serve one year for every day that Jaden has been violently
196	and illegally and unlawfully removed from his mom's care. Julie Kunce Field raped
197	Jaden on December 19, 2011. That means Julie will serve 380 years. Justice served.
198	CONCLUSION
199	Julie Kunce Field is still in control of 2011 DR 444, as stated by multiple law
200	enforcement officers, magistrates and attorneys. Stacy Lynne verbally, in open court,
201	demanded Julie Kunce Field's recusal on November 15, 2011, during the so-called

202	"Permanent Orders Hearing" due to Julie Kunce Field's blatant disregard during the		
203	first 20 minutes of that hearing for the rules, procedures, statutes and laws that		
204	supposedly guide her actions. Further, Stacy Lynne demanded in writing, under oath		
205	and with two sworn witnesses to Field's crimes on the written demand for recusal,		
206	during the lunch break during the November 15, 2011 hearing. Julie Kunce Field's		
207	claim that Stacy Lynne's demand for recusal is not "timely" is provably ludicrous.		
208	Julie Kunce Field's refusal to observe the truth, even when it is written in black		
209	ink on white paper, proves that she is mentally deficient, grossly malfeasant, and/or		
210	recklessly endangering Stacy Lynne and Jaden.		
211	Everybody knows that Julie Kunce Field acted against Jaden's best interests.		
212	Everybody knows that Julie Kunce Field has continuously broken laws.		
213	Everybody knows that Julie Kunce Field abused her power to abuse Jaden to		
214	retaliate against Stacy Lynne.		
215	Everybody knows that Emperor Field has no clothes.		
216	Everybody knows that Julie Kunce Field knows what she is doing to Jaden and
