

Conflicts of Interest for Julie Kunce Field

Bill Ritter (acting as governor for the state of Colorado) appointed **Julie Kunce Field** to be a judge in the 8th Judicial District.

Patricia Stryker pays a major portion of **Bill Ritter's** salary as an employee at Colorado State University.

Julie Kunce Field is listed on state records as sharing a business address, including the same office suite number, with **Patricia Stryker**, the billionaire heiress of the Stryker Medical Corporation.

Julie Kunce Field serves on the board of Crossroads Safehouse, a battered women's shelter that is operated by **Vicki Lutz**.

Vicki Lutz receives tens of thousands of dollars from **Patricia Stryker** to operate Crossroads Safehouse.

Vicki Lutz wrote an article for the *Fort Collins Coloradoan* supporting **Lisa Poppaw** (Fort Collins City Councilor) during a recall attempt that was led by **Stacy Lynne**.

Amy Antommara (attorney for the biological father) called **Lisa Poppaw** as a witness against **Stacy Lynne** during the so-called "permanent orders hearing" for Jaden's "best interests."

Julie Kunce Field allowed **Amy Antommara** to call **Lisa Poppaw** as a witness against **Stacy Lynne** in Jaden's best interests case, even though **Amy Antommara** had no legal or lawful justification to call **Lisa Poppaw** as a witness. **Amy Antommara**, in a secret motion (revealed to **Stacy Lynne** by **Sean Slagle**, **Julie Kunce Field's** clerk) between **Antommara** and **Julie Kunce Field**, lied to the judge when **Amy Antommara** fraudulently claimed that **Stacy Lynne** had a hatred for **Lisa Poppaw**. In fact, **Stacy Lynne** is on public record repeatedly protecting **Lisa Poppaw's** personal character. No such hatred exists from **Stacy Lynne** toward **Lisa Poppaw**.

The record shows that **Lisa Poppaw** was recalled for her robust support of the destruction of locally owned businesses and for her support of fraudulent and so-called “sustainability” goals that were harmful to minority populations and disadvantaged people. Further, **Stacy Lynne** discovered that **Lisa Poppaw** used the Larimer Emergency Telephone Authority system (reverse 911 emergency contact system) to advertise a political meeting.

Stacy Lynne publicly exposed **Patricia Stryker’s** new building as being harmful to small, local business owners because **Bruce Hendee** (**Patricia Stryker’s** architect on the new building with the restricted spaces designed in the plans to achieve the consensus driven [not scientifically derived] status of LEED certification. LEED is the acronym for “Leadership in Environmental and Energy Design” and is not scientifically grounded. LEED does not have a reliable track record for verifying that their expensive mandates improve the environment. The restricted parking spaces in front of **Patricia Stryker’s** new building were limited to the elite people who were wealthy enough to drive “green” cars. ***Stacy Lynne’s** public comments to city council and her public reports about the restricted parking spaces were successful at removing those restricted parking spaces.* **Bruce Hendee** also was the subject of **Stacy Lynne’s** investigations when she discovered that his private company (BHA Design) designed the bicycle racks for the City of Fort Collins “on-street” bicycle parking. **Bruce Hendee** was not required to compete with other private businesses for the contract because the City of Fort Collins conducted a closed-door deal between **Bruce Hendee** and **New Belgium Brewery**. No request for proposals was ever offered to the people. **Bruce Hendee** has now secured a position with the City of Fort Collins as the sustainability director.

Lisa Poppaw attempted to delay the opening of a major grocery store that would serve the north side of Fort Collins because she demanded that the private business meet a higher LEED certification. BHA Design (**Bruce Hendee’s** private company) designed the bicycle racks for that grocery store.

The above noted restricted parking spaces and on street bicycle racks are included in the goals to minimize access to parking by the majority of people who need to drive vehicles to conduct their daily business. The ultimate goal, as defined in the City of Fort Collins “Plan Fort Collins” is to

discourage people from driving cars so they will be encouraged to ride their bicycles and take mass transit instead of driving private, individual vehicles. These goals are expounded upon in a document called the Fort Collins Climate Action Plan. The Fort Collins Climate Action Plan is a document that was prepared by multiple private contractors, including the Brendle Group. The Brendle Group prepares sustainability plans for the cities, towns and counties that belong to the International Council on Local Environmental Initiatives (ICLEI) throughout the United States. ICLEI is in partnership with the United Nations Environmental Program known as Agenda 21. Agenda 21 is implemented locally through ICLEI.

Stacy Lynne's business as an investigative journalist was successful precisely because she avoided personal attacks and personal feelings being used against those officials that she investigated and whom she exposed for fraud and corruption. Stacy Lynne was repeatedly contacted by people from across the political spectrum that possessed injurious personal information that those people hoped Stacy Lynne would use against the officials who were being investigated. Stacy Lynne refused to use any of that personal information in any form. In other words, business and politics was not a *personal* venture in Stacy Lynne's investigations. Stacy Lynne is consistent in her ethical procedures by refusing to enter private, personal information into business and political investigations.

Amy Antommara and **Julie Kunce Field** held a secret hearing with each other on September 13, 2012. That secret hearing was conducted by **Julie Kunce Field** because a valid void judgment was being read onto the record. **Julie Kunce Field** was afraid she would be arrested if the rest of her crimes against **Jaden** and **Stacy Lynne** were read onto the record.

Julie Kunce Field has direct ties to Patricia Stryker and Vicki Lutz. Vicki Lutz has direct ties to Lisa Poppaw. Lisa Poppaw is directly tied to Amy Antommara and Julie Kunce Field. All of these women have been directly impacted by Stacy Lynne's investigative journalism and through Stacy Lynne's public speeches and public and private presentations that exposed the ties each of these women had to questionable relationships.

Julie Kunce Field is the common denominator to Stacy Lynne's political adversaries. That is evidence of undeniable conflicts of interest.
